

Hero Adventure Quest Terms

These Hero Adventure Quest Terms (the “**Quest Terms**”) govern your participation in the Hero Adventure (the “**Quest**”), an interactive online game. These Quest Terms incorporate by reference the NFT Online Inc. Terms of Service (the “**Terms of Service**”) and the applicable NFT Online NFT Terms (the “**NFT Terms**”) and, together with the Terms of Service, the “**NFT Online Terms**”), and any terms used but not defined in these Quest Terms have the meaning given in the NFT Online Terms. In the event of any conflict between the NFT Online Terms and these Quest Terms, the provisions of these Quest Terms will govern to the extent of the conflict.

By entering the Quest, including without limitation by connecting your Digital Wallet to the Service and Entering your Quest Tokens (each as defined below), you acknowledge and agree that you have read, understand, and agree to be bound by these Quest Terms.

1. Definitions:

- a. “**Adventure Contract**” means the self-executing software program through which a User can interact in order to Enter, Play, and otherwise participate in the Quest.
 - b. “**Burn**” or “**Burned**” means, with respect to any NFT (including any Quest Token), that such NFT is sent to a null address, erased, or otherwise rendered permanently inaccessible and/or unusable.
 - c. “**Enter**” means to agree to these Quest Terms and to initiate your interaction with the Adventure Contract through your Digital Wallet, including without limitation by depositing one or more Quest Tokens into the Adventure Contract.
 - d. “**Exit**” means to terminate your participation in the Quest by initiating an exit from the Adventure Contract.
 - e. “**Genesis Token**” means an NFT originally made available by NFT Online and Owned by you that represents one or more digidaigaku.
 - f. “**Hero Token**” means an NFT originally made available by NFT Online that a User may receive, subject to these Quest Terms, as a result of Entering a Quest Token and participating in the Quest.
 - g. “**Play**” means any action you take in connection with, or transaction that you effect through, the Adventure Contract, and may result in a swap, trade, or other exchange of a Quest Token for a different NFT.
 - h. “**Quest Duration**” means one (1) day, beginning on the day that you first Enter the Quest.
 - i. “**Quest Tokens**” means Spirit Tokens and Genesis Tokens.
 - j. “**Redeem**” means a Play that results in Burning a Spirit Token and receiving a Hero Token, in each case in accordance with these Quest Terms.
 - k. “**Spirit Token**” means an NFT originally made available by NFT Online and Owned by you that represents one or more spirits.
 - l. “**Token ID**” means a specific token or NFT identity
2. Eligibility: In order to be eligible to participate in the Quest, you must (i) Own at least one (1) Spirit Token and/or (ii) hold such Spirit Token in the Digital Wallet that you connect to the Service at the time you Enter.
3. Game Play:
- a. You can Enter the Quest with a minimum of one (1) Spirit Token. You can also add additional Quest Tokens to the Adventure Contract during the Quest.

- b. In connection with Entering, you may be able to unlock different rewards (including additional NFTs), and you may be able to “level up” or receive enhanced versions of your existing Quest Tokens.
 - c. Please carefully read the instructions and other documentation provided in connection with the Quest before Entering. The rules applicable to the Quest are subject to change in NFT Online’s sole discretion. Please review the rules of each then-current Play regularly to ensure you are familiar with the then-current terms applicable to your interaction with the Quest. NFT Online shall have no liability to you in connection with any Play or any other interaction with the Quest.
- 4. Exit and Redemption:
 - a. You may Exit at any time.
 - i. If you Exit before the Quest Duration is complete, your Quest Tokens will no longer participate in the Quest and you may request the return of your Genesis Token(s) to your Digital Wallet.
 - ii. If you Exit at any point after the Quest Duration is complete, any Spirit Token(s) that you Played will be Burned and you may Redeem a Hero Tokens for each such Spirit Token that is Burned.
 - b. If you Exit after the Quest Duration is complete, your Spirit Token will be Redeemable for a Hero Token in accordance with the following criteria:
 - i. If you Played a Spirit Token but no Genesis Token, you may Redeem a Rogue Hero.
 - ii. If you Played a Spirit Token and a Genesis Token, but the Token IDs of the Spirit Token and Genesis Token did not match, you may Redeem a Warrior Hero.
 - iii. If you Played a Spirit Token and a Genesis Token, and the Token IDs of the Spirit Token and Genesis Token matched, you may Redeem a Royal Hero.
 - c. NFT Online may, in its sole discretion, remove the Adventure Contract from the Service. In such case, NFT Online will provide reasonable advance notice to you of such removal date. If you do not Redeem any Hero NFT by such date, your ability to Redeem such Hero NFT will terminate in accordance with any terms set forth in such notice.
- 5. Disclaimers:
 - a. An NFT that you receive in connection with or as a result of a Play may have different traits than the Quest Token that you Played, including without limitation traits that represent different elements of rarity or “level” status. NFT Online does not represent that any NFT that you receive from a Play will have similar or equivalent attributes or value to the Quest Token that you Played. NFT Online shall have no liability to you in connection with (i) any Quest Token that you Enter or Play, or (ii) any Hero Token NFT that you receive in connection with the Quest.
 - b. NFT Online does not represent that any Token (including any Hero Token) that you receive from staking will have similar or equivalent attributes or value to the Quest Token that you Entered.
 - c. Any action (including any Play) that results in a Quest Token being Burned is permanent and irreversible. You acknowledge and agree that NFT Online shall not be liable to you in connection with any Quest Token that is Burned as a result of or in connection with your use of the Adventure Contract.
 - d. The Adventure Contract is made available “AS IS” and “WITH ALL FAULTS.” For the avoidance of doubt, Sections 15 and 16 of the Terms of Service apply with full force and effect to any use of the Adventure Contract.
